- Facts are not neutral. Everyone interprets them based on their own presupposition that is their beliefs concerning the origins of knowledge and truth. An individual's belief of the origin of truth interprets the presented facts. As a result, the presented facts are always biased.
- My worldview says facts need examination by the inspired truth of scripture. I believe that the scriptures in their original language and original context are flawless (2 Peter 1: 20 -21). A simple reading of most Bible passages revels their meaning; others require study to peel away bias that I carry.

My worldview biases me. It starts with a kingdom view that starts Malachi 4:5.-6, which extends through Luke 1.17 to the realized kingdom that we now dwell in of Rev 21 and 22. It includes the paradigm that God defines success. Proverbs 13:22 and Job 42:15-16 I understand this to mean that God defines success

not by the results in the current generation but 3-4 generations later. I need to catch a multi-generational vision.

Almost everything in American culture promotes pragmatism and the pursuit of personal pleasure, power and prestige. The Scriptures in my view teach just the opposite, God-centered service and dependence. Again, my worldview sees the solution, to the problems of the family, church and state, as matching bookends. The first involves turning the hearts of the fathers to children and the hearts of the children to the fathers. The second is living in a fully realized presence of God which includes the dimension of salvation from contemporary religious, moral and political cultures.

I understand the world around me and interpret the world around me through the filters of Romans 1:19-20, Psalm 19:1-2 and 2 Timothy 3:16-17. I understand these passages to teach that God had conspicuously revealed everything Man needs for life and Godliness by the destruction of the Temple in AD 70. God revealed some of that knowledge though His inspired words and through His creation. We continue to seek the full meaning of what He revealed to this day even though full knowledge of what God has done has been available for nearly 2000 years.

The Edge of Evolution

The Search for the Limits of Darwinism



 The reason is Darwinian Evolution.

Random changes during viral replication, combined with selective pressures exerted by medicines, allow drugresistant varieties of HIV to prosper in a quintessentially Darwinian process.

Malaria is an ancient scourge of humanity which kills half of all children less than five years old in some part of the world. In the middle of the twentieth century drugs were developed that could cure the disease and hope or eradication surfaced. Yet within a decade the malaria parasites developed resistance to these drugs, with only temporary benefit.



The Battle Between Humanity and Malaria



 Evolution is relentless, brushing aside the best efforts of modern medicine.

Malaria and Evolution



• Malaria has limitations. It cannot reproduce in its mosquito host unless the climate is warm enough. Other organism in nature have developed ways of surviving in subfreezing temperatures.

Sickle Cell Anemia and Mutation



Sickle cell disease is caused by a single genetic change in the portion of the human genome responsible for making hemoglobin. This mutation arose in Africa, perhaps ten thousand years ago. People who have one copy of the gene have resistance to malaria.

The Battle Between Humanity and Malaria



...despite having a thousand-fold more time to deal with the sickle mutation than with modern drugs, malaria has not found a way to counter it. While the evolutionary power of malaria stymies modern medicine, a tiny genetic change in the host organism foils malaria



There is no evidence from the best evolutionary studies that random mutation leads to gene regulatory networks or the complexity of cell differentiation – that is class-level biological distinctions



...work has been done in recent years vielding some persuasive evidence that random changes in existing control networks can helpfully affect animal form at the species level.



 ...random mutation and natural selection can account for many relatively minor changes in life...

 Changes in the appearance of animals, the different sizes and shapes of dogs, the patters of coloration of insect wings, and more can very likely be attributed to Darwinian processes affecting gene switches

- ANY THEORY OF ORIGINS WHICH INCLUDES RANDOMNESS OR DISORDER THAT DOES NOT OFFER GOD AS THE SOLUTION TO THAT RANDOMNESS OR DISORDER IGNORES WHAT THE BIBLE TEACHES ABOUT HOW GOD WORKS IN THE HISTORY OF THE UNIVERSE.
- THE CREATION ACCOUNT DESCRIBES REAL HISTORICAL EVENTS, BUT ALSO HAS MEANING WHICH EXTENDS TO GOD'S PLAN TO CREATE COVENANT WITH MAN.
